## [A] TERMS & CONDITIONS

- Applicant must submit the completed Form to the Forestry Department at least **ONE MONTH** before the intended date of entry into the Forest Reserve.
- The location and duration of entry into the Forest Reserve must be clearly stated in the Form. The maximum validity of Use Permit is for ONE YEAR only.
- Applicant must submit together with this Form the following information:-
  - A copy of applicant's Identity Card/Passport; and
  - o A copy of Identify Card/Passport of each member in the group.
  - o A copy of Labour Department Form 500 / Work Pass / Special Permits or Letter (when necessarily if required)
- Applicant must ensure that this Form is complete. Any incomplete Form and application through e-mail will not be entertained.
- A copy of final report of the project / research / program must be submitted to the Forestry Department through Permit & Licensing Unit after the completion of the project / research / program.
- The Forestry Department will not be responsible for any loss or damage to the property of, accident and injury whether severe or not and involve any loss of life or otherwise to the applicant and group members while inside the Forest Reserve.
